## AIMS AND RULES STATEMENT FOR CINEMA PARADISO

1. **Name:** The Film Club shall be known as 'Cinema Paradiso – Mission Beach Film Club'. Hereinafter referred to in this document as "Cinema Paradiso".
2. **Objects:** The objects of Cinema Paradiso shall be:
  - 2.1 To encourage interest in films as an art form by means of the exhibition of films of all kinds. Cinema Paradiso aims to bring quality cinema to the community of Mission Beach and surrounds, showcasing classical, art-house and foreign film.
  - 2.2 Cinema Paradiso aims to screen 1x per month on a Saturday evening from 7 PM between February & December. To provide a means of bringing the community together on a regular basis in a spirit of goodwill. Cinema Paradiso aims to offer its members a social opportunity on Saturday evenings.
3. **Membership:** Cinema Paradiso will offer the following memberships:
  - 3.1 Membership shall be open to the public at an annual subscription rate which will be fixed by Cinema Paradiso on recommendation of the Committee.
  - 3.2 Temporary memberships should be made available for a minimum of 3 months for tourists and other temporary residents of the area.
  - 3.3 Guests are welcome but after three film viewings members of the public will be asked to join Cinema Paradiso.
4. **Management:**
  - 4.1 Cinema Paradiso will be operating under the umbrella of Mission Beach Community Arts Centre Inc (Mission Arts) – a not-for-profit organization- and will be a sub-committee of Mission Arts.
  - 4.2 The management of Cinema Paradiso shall rest with a committee consisting of not more than **10** members including a President and a Treasurer and such other officers as may from time to time be appointed by Cinema Paradiso who will report back to Mission Arts.
  - 4.3 All members of the committee shall be members of Mission Arts.
  - 4.4 Cinema Paradiso is also a member of the Queensland Federation of Film Societies which is a member of ACOFS – The Australian Council of Film Societies.
5. **Finance:**
  - 5.1 The Treasurer shall maintain a record of all payments and receipts of Cinema Paradiso.
  - 5.2 The Treasurer shall present prior to or at the Members Meetings of Cinema Paradiso a statement of the financial affairs of Cinema Paradiso and how it has changed since the previous Meeting.
  - 5.3 Cinema Paradiso is part of Mission Arts a not-for-profit organization. The funds of Cinema Paradiso shall be used only for the furtherance of the aims of Cinema Paradiso and no part shall be paid or transferred directly or indirectly by way of dividend, bonus or otherwise by way of pecuniary profit to members.
  - 5.4 The members of the committee shall not receive payment either directly or indirectly for their services as members of the Committee.
  - 5.5 Cinema Paradiso may employ such persons as are considered necessary by the Committee for furtherance of Cinema Paradiso's aims and remuneration may be paid to such persons for services actually rendered.

5.6 Cinema Paradiso may operate a bank account but it shall require the signature of two members of the committee to enable withdrawal or payment of funds. At least one Mission Arts committee member must be a signatory on the account.

## 6. Film Selection:

6.1 The Film Selection will be conducted by the committee.

## 7. Members Meetings:

7.1 A Members Meeting will be held once each calendar year. Notice of the meeting shall be in writing and circulated to all financial members at least one month prior to the date of the meeting.

7.2 A report of the activities of Cinema Paradiso since the previous Members Meeting will be made available at each Members Meeting.

7.3 The Committee shall be elected at the Annual Members Meeting and shall hold office for approximately 1 year when a new election will take place.

7.4 A Special Members Meeting may be called at any time by the committee or upon a request in writing being made to the President and signed by at least one tenth of the financial members of Cinema Paradiso stating the nature of the business.

7.5 The President shall give at least fourteen days' notice of a Special Members Meeting to all financial members of Cinema Paradiso; the notice shall be in writing, stating the nature of the business to be discussed.

## 8. Alteration of the Aims Statement:

8.1 No alteration to the Aims Statement shall be made except at an Annual Members Meeting or a Special Members Meeting of Cinema Paradiso, provided that any proposed alteration will have been circulated in writing to all financial members at least one month prior to the meeting and that the proposals shall be supported by a two-thirds majority of the financial members.

9. **Winding Up:** Cinema Paradiso will not be wound up except by resolution of three quarters of those members present at a Special Members Meeting called for the purpose. In the event of the winding up of Cinema Paradiso the remaining assets and funds shall not be distributed amongst members of Cinema Paradiso, but will go to Mission Arts to hold in trust for future film related projects.
